EasyPay Terms & Conditions

In order to make our overseas events more affordable and available to all, Walk the Walk in Action Limited (WWA) is offering all entrants the opportunity to spread their payments for the total package cost, including entry and admin fees, travel and accommodation, over many months in the period leading up to the event.

This offer is subject to the following terms and conditions:

1. An initial payment (the deposit) comprising the Booking Deposit fee, the WWA Admin fee and the race entry fee (if applicable) must be made on application. Any extra costs above the basic tour price e.g. for additional T-shirts etc. will also be included in this initial payment. Supplements e.g. for single rooms, may be included in the deposit or spread across the Easy Pay payments. For cancellations within seven days of application the deposit is refundable; after this period it is not refundable.
2. Payment of the deposit by credit card or via the online entry form will be subject to a 2% fee.
3. When you pay the deposit you can opt to pay the balance in a lump sum, two instalments or by Easy Pay instalments. In either case full payment is to be made by the date specified on the entry form.
4. If you opt for Easy Pay instalments, these must be paid by Standing Order to your bank. We are a relatively small charity with limited resources and this method is more efficient and cheaper (no card fees) for both of us. A Standing Order form is enclosed for you to complete and sign and return to us (c/o the Finance department at Walk the Walk); we will then check & complete it and send it on to your bank. Please note it is your responsibility to ensure that each payment is made on time and that there are sufficient funds in your account for each payment as it becomes due.
5. If you use online banking and wish to set up a Standing Order online, please contact our Finance Department to obtain a reference number to include on the mandate (so that we can recognise your payments to us) and subsequently send us confirmation that the Standing Order has been set up.
6. If you cancel your Standing Order please let us know together with the reason. We will call you if we do not receive your payment on the due date, but as we have limited resources we will do this only once; thereafter if payment is not made within a day of the due date we may cancel your right to the Easy Pay scheme and the balance of your trip will be due by the date specified on the entry form.
7. If you do not pay the balance of your trip by the date specified on the entry form we reserve the right to cancel your trip, and refund any monies paid less the deposit, the WWA administration fee and any cancellation charges applied by our Tour Operator.
